#### **Community Events and Updates**

Parent Information Center: offering the parent night as part of the Inclusion Conference; parent speaker will discuss accessible instructional materials (AIM)

DNEA will be partnering with the Autism and Law Enforcement Educational Coalition (ALEC) to support a train the trainer program for first responders & ASD

#### Family needs report

76 new contacts reported this quarter

Families are calling with issues related to IEPs: families don't know how to request information and advocacy or sit through meeting with them and/or the District is suggesting an unwanted services. Autism DE sit and support family.

#### **DSAMH** Presentation

- PROMISE Program
  - Program started January 2018 to serve individuals in the least restrictive environment. Focused on those transitioning from PBH to DSAMH services
    - Aging out (18 plus)
    - Severe mental illness
    - Functional issues within the community
    - Have to choose to accept these services
  - Program comes from gaps in services seen during transition age
  - Offers: Peer supports, personal care supports
  - The team will: follow clients, provide advocacy, monitor services to make sure they are receiving appropriate services, review annual to make sure level of care is appropriate, review as necessary
  - Can start processing from age 17 ½
  - Work in partnership with DDDS for specific complicated cases

### **Quarterly Strategic Plan Update**

- Educational Classification/Medical Diagnosis of ASD
  - DOE and DNEA are talking with stakeholders about the evaluation process
    - Developiong tool box for educational classification process
  - Building Bridges is developing resource guides- to help families understand the medical evaluation/ educational classification process
  - The DNEA is artnering with the Thompson Center at the University of Missouri to develop a training on medical diagnosis of ASD
- Disscusion on lack of ABA services- particularly in Western Sussex
- DNEA will connect ABC Consulting with Bayhealth to continue work on hospital initiative

#### **Identifying Priorities**

- Discussion on how to identify DNEA priorities and determination of when priorities are met
  - DNEA will create SMART goals for each priority and review with the ICA
    Use logic models as a guide
  - Add a status update to DNEA priority update
- ICA members should also be identifying and reporting on activities
  - Discussion led by Brian Hall- ensuring the ICA is reviewing the Blueprint and reporting on its activities
  - How best to do this?

#### **DNEA Funding**

- DNEA was not given funding within Governor's draft budget
  - Next steps: Autism DE reached out to Representative Jaques to talk about DNEA and 292 (meeting occurring tomorrow)
- Looking for ways to be creative with funding for next year
  - State agencies with federal grants
- DNEA Director
  - A few interviews are being set up with promising candidates
    - The ICA will be invited to candidate presentations
