- B. Funding (Sarah Mallory)

1. Begins every fall with Health Fund Advisory Committee (HFAC)

a) HFAC approved DNEA proposal with a 15% increase

2. DNEA currently included in Governor's Budget

a) Joint Finance Committee (JFC) did not raise any concerns with DNEA budget

- C. Potential training and technical assistance activities (Alisha Fletcher)
 - 1. Training that supports professionals in using the ADOS

a) Discussion: DDOE shared that they collaborated with DOSAP to hold virtual ADOS training. Norman Geller provided the training. DNEA will follow up with DDOE, DOSAP, and others to potentially offer second training this year.

2. Resources for healthcare providers: Visual task analysis of common medical procedures to be distributed, with training/technical assistance resources, to medical providers

3. Resources for peer education: OAR offers Kits for Kids, which teaches peers about autism acceptance, while supporting inclusion

a) Discussion: Could organize ambassadors and distribute to after school programs. Potential programs include: YMCA, JCC, summer camps, Delaware Children's Museum, Delaware Art Museum
