III. DNEA Updates

- 1. CDS Team
 - Funding update
 - Supported decision making efforts
 - DNEA training numbers were reported by training tier and by county across the state.
 - First responder work
 - Autism first responder trainings, mock driving program (new initiative they are working on), and disaster preparedness were mentioned.
 - Questions/comments:
 - Isabel Rivera-Green stated that the DMV and driving guides created for the First Responder work are very good ideas. She asked if they will be accessible on the DNEA website.
 - Sarah Mallory said yes, once it is ready it will be published on the DNEA website.
 - Jennifer Aaron asked for the mock driving program where it will be held and who do they contact to participate.
 - Alisha Fletcher answered that hopefully it will be available in each county across the state. There will be a sign-up for this part on the webpage for the program and updates will be in the DNEA email.
 - Mary Whitfield asked if the DNEA statewide trainings are being offered to k-12 educators.
 - Sarah Mallory answered and said that she and Mary can meet separately to discuss further.
 - Jennifer Aaron asked if the mock driving training can be done in the schools for the driving programs they have.
 - Sarah Mallory answered that the DNEA doesn't have a firm plan, the school districts usually have their own person on staff for the driving programs. However, once the accompanying resources are completed, it would be a good conversation to have.
- 2. Autism Delaware Team
 - Currently hiring 3 FSPs and a program manager
 - Parent and grandparent coffee hours, in-person groups have restarted and virtual are still available
 - 25th anniversary gala on November 11th from 6-10pm
 - Please share the invitation with others
 - Brian Hall shared about the training through HRSA that happened in June 2023 around navigation models happening across the country.
 - Learned that Delaware is leagues ahead of a lot of places at

the moment and that some other states only have a very small staff that runs family supports. It came up that different states refer to family support and navigation differently

• It was alluded to that there is the potential for new funding.

IV. ICA Workgroup/Subcommittee Discussion

- 1. Holding and conducting workgroups and subcommittees at the end of meetings is difficult. There is not enough time and some people can't attend
 - We want to have a discussion about changing when the workgroups/subcommittees meet. These meetings would be posted to public meeting calendar with an agenda and meeting minutes.
- 2. Proposed Maintain 1 ½ hour meetings every other month with workgroup meetings separately
- 3. Brian Hall mentioned the following.
 - It probably makes sense, for the adult committee, they need a restart. After making sure that we have everyone's emails, it makes sense to use this big meeting as just time to report out.
 - If we agree to make this shift, can workgroup leads be provided with the list of workgroup members?
 - Sarah Mallory, Meredith Tavani, and Katie Booz will meet with the leads of the workgroups to discuss moving forward. We need to follow public meeting laws and we want to keep a framework across all workgroups. Anything that is official ICA business needs to be published on the public meeting calendar. The workgroups would only need to meet quarterly.
- 4. It was mentioned in previous meeting minutes that Brian Freedman liked the idea of having his workgroup meet outside of the general meeting
- 5. Official Vote on this proposal:
 - Motion: Move to hold workgroups and subcommittees outside the normal meeting the bi-monthly ICA meetings Brian Hall

- 6. The DNEA team will get ahold of the leads to begin this orchestration and begin next steps.
- 7. Brian Hall asked if we want to have a timeframe for when to meet by this first time.
 - Sarah Mallory responded that for the timelining on the DNEA's end, Katie Booz will disseminate meeting minutes within a week. Once we get them out, Katie will reach out the leads for each workgroup to organize an initial meeting. We have 2 months until our next ICA meeting, should we add this to the agenda? Or have a workgroup meeting before then?
 - The DNEA will share the proposal timeline at next ICA meeting.
 - If it would be helpful, and if it's agreeable to everyone, the DNEA can provide administrative support for workgroups. Please give the DNEA time to look at calendars and get an idea.
